



## Take to the skies to raise smiles!

Thank you for signing up for a Skydive. Together, we will raise awareness and vital funds for babies, children and young people living with life-limiting conditions, and their families, across the South West.

This pack has information and materials to help with your fundraising, including top tips, a fundraising event poster and sponsor form. Don't forget to join our Be Incredible Facebook group to share your fundraising and photos.

£450...

could help pay for 3 days of Music Therapy to help express thoughts and feelings.

£900...

could help to fund a children's nurse to provide care for babies, children and young people for 1 week.

£1,500...

could help fund 24 hours of round the clock care for a baby, child or young person nearing their end of life.



## 😊 How much sponsorship do I need to raise?

You will have already paid a £50 non-refundable deposit when booking, then our charity-funded place skydive participants are asked to raise a minimum sponsorship of **£400** before your skydive date to confirm your jump. This is broken down as:

- 😊 £200 balance of the cost of your skydive to be received by CHSW 4 weeks before your skydive date. If this is raised via your sponsor form, you will need to pay CHSW 4 weeks before your skydive date. If this is raised through your online fundraising page, it will automatically be received by CHSW
- 😊 £200, plus any additional fundraising before or after your skydive, will go to Children's Hospice South West to care for babies, children and young people living with life-limiting conditions, and their families.

As your sponsorship is paying towards the charity-funded skydive, you will need to be transparent with your donors. We are unable to claim Gift Aid on the first £400 raised towards your skydive. Therefore, to make things simple we advise the following:

- 😊 When setting up your online fundraising page please do not allow Gift Aid to be claimed
- 😊 Do not allow donors on your sponsorship form to tick the Gift Aid box
- 😊 Add this clear statement to your online giving page and sponsorship form:  
£200 of the sponsorship raised will be funding the Skydive and the remaining sponsorship will support care at Children's Hospice South West.

## 😊 Collecting your fundraising

**Fundraise online.** Simple to set up and means you have no money to collect! Set up an online giving page on Facebook, or at [justgiving.com](http://justgiving.com)

**Contactless donations.** CharityGo mobile app turns your smart phone into a card reader to take safe and secure donations from credit and debit cards as well as digital wallets, such as Apple Pay, Google Pay and Samsung Pay. Visit [chsw.org.uk/charitygo](http://chsw.org.uk/charitygo) to get started.

**Cash donations.** Use the sponsor form included, collect cash and pay in donations online or by sending a cheque in the post.

- 😊 Hold a dress-down day at your workplace in return for a donation
- 😊 Always have your sponsor form ready so you don't miss any donations
